The declaration should include the following information: The SRO shall confirm that the PI and the members of the project team are/will be employed in that SRO during the implementation of the Project, and that the SRO supports the application and the proposed Project. The SRO shall confirm that it will provide the space and equipment specified in the proposed Project. The SRO shall confirm that it accepts the responsibilities defined in the Project Contract with the Fund. Note. If the PI and the members of the project team will be employed in several SROs, one declaration for each SRO should be prepared. The declaration must be signed and stamped by the official representative of the SRO. The document shall be prepared in Serbian. 	Proof of research or academic title	Proof of research or academic title for all members of the project team. All members of the project team must hold a title in

		 research or science or an equivalent title in higher education. Proof should be issued by: the ministry in charge of science for Research Associate, Senior Research Associate and Principal Research Fellow; a SRO for Junior Research Assistant and Research Assistant; a university or faculty for Junior Teaching Assistant, Teaching Assistant, Teaching Assistant with Ph.D., Assistant Professor, Associate Professor and Full Professor.
